Rationale

At St Augustine of Canterbury Catholic Primary School, we recognise that bullying can occur. When it does it can be harmful both physically and emotionally for the victim. It can also be a sign that the child carrying out the bullying has underlying issues that need to be addressed. The purpose of this policy is to enable adults in the school and parents to recognise bullying when it takes place and to deal with it effectively. It must be made profoundly clear that we will **not** tolerate bullying at St Augustine of Canterbury Catholic Primary School.

Here at St. Augustine of Canterbury Catholic Primary School we create an ethos of good behaviour; where children treat one another and the school staff with respect because they know that this is the right way to behave. That culture extends beyond the classroom to the corridors, the dining hall, the playground, and beyond the school gates including travel to and from school and online. Values of respect for staff and other children, an understanding of the value of education, and a clear understanding of how our actions affect others permeate the whole school environment and are reinforced by staff and older children who set a good example to the rest.

Objectives of this Policy

- All governors, teaching and non-teaching staff, children and parents should have an understanding of what bullying is.
- All governors and teaching and non-teaching staff should know what the school policy is on bullying, and follow it when bullying is reported.
- All children and parents should know what the school policy is on bullying, and what they should do if bullying arises.
- As a school we take bullying seriously. Children and parents should be assured that they will be supported when bullying is reported.
- Bullying will not be tolerated.

- Parents/carers to support their children and work in partnership with the school.
- Children to abide by the policy.

Aims and School Ethos

We are committed to providing a caring, friendly and safe environment for all of our children so they can learn in a relaxed and secure atmosphere. Bullying of any kind is unacceptable at our school. If bullying does occur, all children should be able to tell and know that incidents will be dealt with promptly and effectively. We are a TELLING school. This means that *anyone* who knows that bullying is happening is expected to tell the staff.

St Augustine of Canterbury Catholic School recognises that all forms of bullying, especially if left unaddressed, can have a devastating effect on individuals; it can create a barrier to learning and have serious consequences for mental wellbeing. By effectively preventing and tackling bullying our school can help to create a safe and disciplined environment, where children are able to learn and fulfil their potential.

Our School Community:

- o Understands the importance of challenging inappropriate behaviours between children.
- o Monitors and reviews our anti-bullying policy and practice on a regular basis.
- o Supports staff to promote positive relationships to help prevent bullying.
- o Recognises that some members of our community may be more vulnerable to bullying and its impact than others; this may include children with SEND. Being aware of this will help us to develop effective strategies to prevent bullying from happening and provide appropriate support, if required.
- o Will intervene by identifying and tackling bullying behaviour appropriately and promptly.
- o Ensures our children are aware that bullying concerns will be dealt with sensitively and effectively; that everyone should feel safe to learn and abide by the anti-bullying policy.
- o Requires all members of the community to work with the school to uphold the antibullying policy.
- o Recognises the potential impact of bullying on the wider family of those affected so will work in partnership with parents/carers regarding all reported bullying concerns and will seek to keep them informed at all stages.
- o Will deal promptly with grievances regarding the school response to bullying in line with our complaints policy.
- o Seeks to learn from good anti-bullying practice elsewhere.
- o Utilises support from the Local Authority and other relevant organisations when appropriate.

Safeguarding children and young people DFE 'Preventing and tackling bullying Advice for headteachers, staff and governing bodies': July 2017

When there is 'reasonable cause to suspect that a child is suffering, or is likely to suffer, significant harm' a bullying incident should be addressed as a child protection concern under the Children Act 1989. Where this is the case, the school staff will discuss with the Designated Safeguarding Lead (Louise Prestidge) or Deputy Designated Safeguarding Leads (Claire Burns and Angela Liggins) and report their concerns to Medway Children's Services/Education Safeguarding and work with them to take appropriate action.

Responsibilities

It is the responsibility of:

The headteacher to communicate this policy to the school community, to ensure that disciplinary measures are applied fairly, consistently and reasonably, and that a member of the senior leadership team has been identified to take overall responsibility.

Governors to take a lead role in monitoring and reviewing this policy.

All staff, including governors, senior leadership, teaching and non-teaching staff, to support, uphold and implement this policy accordingly.

Parents/carers to support their children and work in partnership with the school.

What Is Bullying?

DFE 'Preventing and tackling bullying Advice for Headteachers, staff and governing bodies': July 2017

Bullying is behaviour by an individual or group, repeated over time, that intentionally hurts another individual or group either physically or emotionally.

Bullying can include name calling, taunting, mocking, making offensive comments; kicking; hitting; taking belongings; producing offensive graffiti; gossiping; excluding people from groups and spreading hurtful and untruthful rumours.

This includes the same unacceptable behaviours expressed online, sometimes called online or cyberbullying. This can include: sending offensive, upsetting and inappropriate messages by phone, text, instant messenger, through gaming, websites, social media sites and apps, and sending offensive or degrading photos or videos.

Bullying is recognised by St Augustine of Canterbury Catholic Primary School Primary as being a form of child on child abuse; children can abuse other children.

- Abuse is abuse and it should never be tolerated or passed off as "banter", "just having a laugh" or "part of growing up".
- We recognise that even if there are no reports of bullying, it does not mean it is not happening and it may be the case that it is just not being reported.
- All victims will be taken seriously and offered appropriate support, regardless of where the abuse takes place.

St Augustine of Canterbury Catholic Primary School recognises that bullying can be emotionally abusive and can cause severe and adverse effects on children's emotional development.

This policy covers all types and forms of bullying including:

Bullying can happen to anyone. This policy covers all types and forms of bullying including but not limited to:

- o Bullying related to physical appearance
- o Bullying of young carers, children in care or otherwise related to home circumstances
- o Bullying related to physical/mental health conditions
- o Physical bullying
- o Emotional bullying
- o Sexual bullying/harassment
- o Bullying via technology, known as online or cyberbullying
- o Prejudicial bullying (against people/children with protected characteristics):
- o Bullying related to race, religion, faith and belief and for those without faith
- o Bullying related to ethnicity, nationality or culture
- o Bullying related to Special Educational Needs or Disability (SEND)
- o Bullying related to sexual orientation (Homophobic, biophobic and transphobic (HBT) bullying).
- o Gender based bullying, including transphobic bullying
- o Bullying against teenage parents (pregnancy and maternity under the Equality Act)

Cyber-bullying/Online bullying

The rapid development of, and widespread access to, technology has provided a new medium for 'virtual' bullying, which can occur in or outside school. Cyber-bullying is a different form of bullying and can happen at all times of the day, with a potentially bigger audience, and more accessories as people forward on content at a click.

Cyberbullying

At St. Augustine of Canterbury Catholic School, we follow Childnet Cyberbullying guidance

When responding to cyberbullying concerns, we will:

- Act as soon as an incident has been reported or identified.
- Provide appropriate support for the person who has been cyberbullied and work with the person who has carried out the bullying to ensure that it does not happen again.
- Encourage the person being bullied to keep any evidence (screenshots) of the bullying activity to assist any investigation.
- Take all available steps where possible to identify the person responsible. This may include:
 - looking at use of the school systems;
 - identifying and interviewing possible witnesses;
 - Contacting the service provider and the police, if necessary.
 - Work with the individuals and online service providers to prevent the incident from spreading and assist in removing offensive or upsetting material from circulation. This may include:
- Support reports to a service provider to remove content if those involved are unable to be identified or if those involved refuse to or are unable to delete content.
- Confiscating and searching children's electronic devices, such as mobile phones, in accordance with the law.
- Ensure that sanctions are applied to the person responsible for the cyberbullying; the school will take steps to change the attitude and behaviour of the bully, as well as ensuring access to any additional help that they may need.
- Inform the police if a criminal offence has been committed.
- Provide information to staff and children regarding steps they can take to protect themselves online.

This may include:

- advising those targeted not to retaliate or reply;
- providing advice on blocking or removing people from contact lists;
- helping those involved to think carefully about what private information they may have in the public domain.

Supporting Children

Children who have been bullied will be supported by:

- Reassuring the children and providing continuous support.
- Offering an immediate opportunity to discuss the experience with their teacher, the Designated Safeguarding Lead (Louise Prestidge), or a member of staff of their choice.
- Being advised to keep a record of the bullying as evidence and discuss how respond to concerns and build resilience as appropriate.
- Working towards restoring self-esteem and confidence.
- Providing ongoing support; this may include: working and speaking with staff, offering formal counselling, engaging with parents and carers.
- Where necessary, working with the wider community and local/national organisations to provide further or specialist advice and guidance; this could include support through Early Help or Specialist Children's Services, or support through Children and Young People's Mental Health Service (CYPMHS).

Children who have perpetrated the bullying will be helped by:

- Discussing what happened, establishing the concern and the need to change.
- Informing parents/carers to help change the attitude and behaviour of the pupil.
- Providing appropriate education and support regarding their behaviour or actions.

- If online, requesting that content be removed and reporting accounts/content to service provider.
- Sanctioning, in line with school behaviour/discipline policy; this may include official warnings, removal of privileges (including online access when encountering cyberbullying concerns), and fixed-term or permanent exclusions.
- Where necessary, working with the wider community and local/national organisations to provide further or specialist advice and guidance; this may include involvement from the Police or referrals to Family Solutions/Early Help, Specialist Children's Services, or Children and Young Person's Mental Health Service (CYPMHS).

Strategies for the prevention and reduction of bullying

Preventing and raising awareness of bullying is essential to keeping incidents in our school to a minimum. Through assemblies as well as PSHE/RSHE lessons, children are given regular opportunities to discuss what bullying is, as well as incidents we would not describe as bullying, such as two friends falling out, or a one-off argument.

Whole school initiatives and proactive teaching strategies will be used throughout the school to develop a positive learning environment with the aim of reducing the opportunities for bullying to occur. These include:

- PSHE and RSE teaching
- Involve children in anti-bullying campaigns in schools and embedded messages in the wider school curriculum.
- Awareness through anti-bullying assemblies throughout the year, children are encouraged to generate ideas and take ownership of anti-bullying activities and events, deliver assemblies and anti-bullying sessions to peers and be actively involved in writing school behaviour and anti-bullying policies.
- Circle time
- Drama/role play activities
- Playground Buddies for new children who are settling into school
- By following of the whole school behaviour policy which includes using praise and rewards to reinforce good behaviour; encouraging the whole school community to model appropriate behaviour towards one another.
- Playground monitors and Leaders in both the Infants and Juniors. The key component is to provide peer-to-peer support for children and a valuable point of liaison between children and staff. Playground friends and leaders are highly visible, wearing different coloured tabards and receive specific training for their role.
- Monitor and review our anti-bullying policy and practice on a regular basis.
- Support staff to promote positive relationships to help prevent bullying.
- Regularly canvas children's views on the extent and nature of bullying.
- Ensure that all children know how to express worries and anxieties about bullying.
- Ensure that all children are aware of the range of sanctions which may be applied against those engaging in bullying.
- Publicise the details of internal support, as well as external helplines and websites.

Role of Parents

Parents have an important part to play in our anti bullying policy. We ask parents to:

- Look out for unusual behaviour in their child - for example not wanting to attend school, feeling ill regularly, or not completing work to their usual standard.
- Always take an active role in your child's education, enquire how their day has gone, who they have spent time with etc.
- If you feel your child may be a victim of bullying behaviour, inform the school. Your complaint will be taken seriously and appropriate action will follow.
- If you feel a child has bullied your child, please do not approach that child in the playground or on their way home. Please inform the school immediately.
- It is important that you do not advise your child to fight back or to repeat the bully's behaviour. This will only make the situation worse.
- Tell your child it is not their fault they are being bullied.
- Reinforce the school policy on bullying and ensure your child is not afraid to ask for help.
- If you know your child is involved in bullying, please discuss the issues with them and inform the school. The matter will be dealt with appropriately.

Signs and Symptoms

Staff and Parents should be vigilant in looking out for signs of bullying or other child protection issues including:

Physical: *unexplained bruised, scratches, cuts, missing belongings, damaged clothes, or schoolwork, loss of appetite, stomach aches, headaches, bedwetting.*

Emotional: *losing interest in school, withdrawn, secretive, unusual shows of temper, refusal to say why unhappy, high level of anxiety, mood swings, tearfulness for no reason, lack of confidence, headaches and stomach aches, signs of depression.*

Behavioural: *asking to be taken to school, coming home for lunch, taking longer to get home, asks for more money, using different routes to school, 'losing' more items than usual, sudden changes in behaviour and mood, concentration difficulties, truancy.*

These signs and behaviours could indicate other problems, but bullying should be considered a possibility and should be investigated.

Procedures for reporting and responding to bullying incidents

Allegations and incidents of bullying at St Augustine of Canterbury Catholic Primary School will be taken seriously by all staff and dealt with impartially and promptly. All of those involved will have the opportunity to be heard. Staff will support all children involved whilst the allegations and incidents are investigated and resolved.

The following procedures are to be followed:

- Incidents of reported bullying need to be reported to the class teacher in the first instance who will inform a member of the SLT/Deputy/Headteacher. The class teacher will speak to all children involved about the incident separately or if appropriate as a group. This will be reported to the SLT/Deputy/Headteacher.

The problem will be identified and possible solutions agreed.

- Staff will attempt to adopt a problem-solving approach through circle times and/or drama activities which will move children on from having them to justify their behaviour.

- Appropriate action will be taken to end the bullying behaviour or threats of bullying.

- The bully (bullies) may be asked to genuinely apologise. Other consequences may take place and appropriate sanctions applied i.e. loss of playtimes etc in accordance with the sanctions listed in our behaviour policy

- If possible, the children will be reconciled.
- An attempt will be made and support given to help the bully (bullies) understand and change his/her behaviour.
- If the bullying continues, parents will be informed and invited into the school for a meeting to discuss the problem.
- Meetings, with both parents and children present, may be used to resolve the issues.
- All reported incidents of bullying will be recorded and kept on file.
- In repeated or serious cases the school may follow the following sanctions:
 - Lunch time inclusion/exclusion
 - Suspension exclusion
 - Permanent exclusion

Monitoring of Policy

This policy will be monitored by the Headteacher and through staff meetings and will be reviewed annually. Following an annual review, suggestions for amendments will be presented to the school council and shared with the whole school community during Anti Bullying Week every November.
